

COVID-19 Vaccination Resources for Community Entities

The New York State Association of County Health Officials (NYSACHO) is proud to provide your organization with an outreach toolkit with messaging that follows the New York State Department of Health and Centers for Disease Control and Prevention (CDC) COVID-19 safety guidelines. This toolkit can be utilized to effectively communicate with individuals and families in the communities that you serve. While on May 11, 2023, the national public health emergency (PHE) declaration for COVID-19 ended, the end of the emergency declarations does not mean the virus is no longer a threat. The virus remains a <u>leading cause of death</u> in the United States, with about 250 daily deaths on average. Visit <u>CDC's website</u> and your state and local health departments for information about local infection rates and recommended precautions.

Within this toolkit, you will find messaging in letter and email format that you can simply copy and paste for distribution. You can also find rack cards that can be printed through your local print shop and distributed in a timely manner.

Talking Points

COVID-19 Vaccination Resources for Community Entities

Since COVID-19 vaccinations are relatively new, it makes sense that individuals might have concerns. Anyone may feel overwhelmed by the sheer volume of information—and false information—about COVID-19 vaccinations. You can assist by lending them a kind ear and figuring out the root of their concerns.

Getting a COVID-19 vaccine reduces the risk that an individual will:

- Get seriously ill, require hospitalization, or die from COVID-19.
- Spread the disease to others, putting their health and lives at risk.

Vaccinating as many people as possible is the best way to reduce:

- The spread of COVID-19.
- The chance of future, more dangerous variants developing.

The COVID-19 vaccines are safe:

• Hundreds of millions of people in the United States have safely received COVID-19 vaccines under the most intense safety monitoring in U.S. history.

Side effects from COVID-19 vaccines:

- COVID-19 infection is a greater risk to your health than any potential vaccine side effects.
- Serious side effects and allergic reactions are extremely rare. These rare side effects are generally treatable, and last only a short time.
- There is no evidence that COVID-19 vaccines can lead to long-term health problems, such as infertility or cancer.
- COVID-19 infection can leave you with heart and lung damage and other conditions that require long-term treatment.

Access is key to ensuring more people get vaccinated against COVID-19!

- Connect individuals you serve to places in your community where the COVID-19 vaccine is available (pharmacies, local health department, community organizations, etc.).
- Connect with your local health department or other medical offices to provide pop-up COVID-19 vaccine clinics at your organization.
- When possible, assist individuals with making vaccine appointments at other locations.







When responding to a comment, positive or negative, never insert your own opinion. Always provide factual answers to a question or direct the person to visit the CDC website for more information.


