

Template Letter to Families

This customizable template for Pediatricians and Family Practitioners can be utilized to send to families either via mail or email encouraging and reminding them to return to the office for well-child visits and vaccinations prior to returning to school. Be sure to include this message on your organization's letterhead.

With the new school year approaching, we hope that this note finds you and your family safe and healthy! We appreciate your ongoing flexibility and understanding as we adjust office protocols in accordance with the New York State Department of Health and Centers for Disease Control and Prevention (CDC) safety guidelines to keep patients and families as safe as possible during this COVID-19 health crisis.

New Yorkers are encouraged to schedule necessary health care visits including regular checkups, physicals and routine immunization visits. As a reminder, all kids going to public, private and religious schools, pre-K and day care, must get all required vaccinations unless they have a valid medical exemption. Requirements will differ based on your child's age and their immunization history or health record.

Sample Phone Call Script


