S8565	<p><b>ASHBY</b> -- Allows courts to consider the risk of continued substance abuse  <b>No Same as</b>  <b>Primary Law:</b> Criminal Procedure Law  <b>BLURB :</b> CP L. substance abuse risk  <b>SUMM :</b> Amd §§510.10, 530.20, 530.40, 510.30 &amp; 140.20, CP L Allows courts to consider the risk of continued substance abuse and likelihood of serious harm to the principal when considering committing</p>

such principal to the custody of the sheriff.
